

## Dr. Rob Wennerberg

1. What is your current practice in psychology?

Currently I work for the UC Davis EAP as a post-doctoral intern. I sit on the workplace violence committee doing threat assessments with a team of other professionals, and I provide departmental consultations and debriefings as necessary.



I have a BS in Cellular Neuroscience from Tulane University in New Orleans, an MA in Forensic Psychology from the University of Denver, and a PsyD from Pepperdine University in Malibu

3. What interesting jobs have you had outside psychology?

One job I've had for ten years and continue to have is as a Wedding Photographer and Floral Designer. I have my own business and I travel all over the United States doing weddings, from Chicago, to Baltimore, and this summer even up into Canada. It's a very fun and interesting job and it provides a good balance for some of the heavy work we do as psychologists. Another interesting job was as an EMT in New Orleans for 3 years. You get to see a lot of raw trauma as an ambulance driver in such a town.

4. What challenges do you see ahead for our profession?

Now there is a big question. The easy answer is that I see we will continue to have turf wars regarding MA vs. Dr. level trained professionals. The Psychologist field appears to be the shrinking middle, as psychiatrists expand their offerings into therapy and more and more managed care plans prefer to pay an MA level therapist less for the same work. I think the field of Dr. level psychology really needs to take a strong role in advocacy, policy making, leadership, and substantive research. We also need to provide more international outreach and expand our humanitarian footprint. I laugh when people ask what I ant to do because I want to do everything!

5. Why are you a member of NSPA?

Because the people are cool. But really, because it provides me an outlet for creativity (the website) an ability to work with psychologists that have been in the field much longer than myself, because I'm a natural "go-getter" and because of policy and leadership opportunities with CPA.

6. Tell us one other interesting thing about you.

I have helped birth a baby in the back of an ambulance... it was never on my bucket list but it's pretty interesting. Maybe also that I have a significant other that is being deployed to Afghanistan in January which is a new experience and I'm learning a great deal about the experiences military families go through.





### Resumption of NSPA's Annual Outstanding Contribution to Mental Health Award

In the Executive Board meeting on 9-21-11, the suggestion was made that NSPA resume our "annual" award presented to the person and/or entity that has made a significant and impactful contribution to the mental health of our community. This award, known as NSPA's *Outstanding Contribution to Mental Health Award*, was last given in 2004, when it went to the Drug Courts of both Napa and Solano Counties. In a crowded ceremony at the former River City Restaurant, Judge Richard Bennett accepted the award for the Napa Drug Court, and a judge from Solano County accepted the award for that county. We presented a hand-some plaque to each county, and the Napa plaque hung conspicuously in the front foyer of the Criminal Courts Building for six years!

So, do you know someone or an entity/institution that deserves this kind of recognition? We want to hear from you! Heretofore, the awards consisted of a plaque and some good publicity for the recipient (also for NSPA!). This year, however, we may be able to "amp-up" the award a little bit, thanks to a little surplus in our coffers! Your Executive Committee approved \$500 for the award (either in cash or equipment), to be given in 2012.

- 4. Once this is complete you have to be patient and wait. You will receive an e-mail within 24hrs from members-request@napapsychologists.org with a huge long title like... "confirm 8c0c8d7242a258fd90e8a8e0197315206c4825d0"
- 7. All you need to do when you get the e-mail is reply to it. The system will verify that you were not erroneously added to the list and voila! You're done.
