Creative recovery: Working with natural creativity to address addiction

CPA Governmental Affairs Committee (GAC) Update

The state system has been busy considering laws that directly affect us as psychologists. With the support of local chapters, and the dedication of our colleagues at the state capitol, a full mental health parity bill AB 154 (Beall) was passed through the state assembly with a 100% partisan vote. This Bill, sponsored by democratic assemblyman Jim Beall from San Jose, would expand mental health coverage requirements to all disorders defined in the DSM-IV TR not including nicotine dependence. This would be an expansion of current law that only requires insurance companies to cover "severe mental illness." The bill will now go before the State Senate Health Committee for further approval.

A second state bill, AB 369, also passed the assembly. That bill would bar health insurance companies from requiring lower cost medications be attempted before the prescribing doctor's original prescription can be used. This has been seen as a negative insurance provider influence over best medical practices and has affected the field of psychology through psychiatric availability to appropriate medication options. Each of these bills still face challenges in our complex legal system but have cleared major hurdles on their way to becoming law.

Meet Your Membership Chair

1. What is your current practice in psychology?

My practice is fully forensic at this time, with about 70% of my work coming from the California Department of Mental Health (DMH), about 25% from the Napa Superior Court and Napa County Mental Health, and about 5% from other private sources, such as defense attorneys, District Attorneys and various agencies (e.g., Regional Centers). I have a contract with DMH to perform Sexually Violent Predator Evaluations, which requires me to evaluate inmates in various prisons in Northern and Central California, and then to testify in court on those evaluations, if needed. I also have a contract with Napa Superior Court to perform forensic evaluations, such as competency to stand trial, state of mind assessments (i.e., the Not Guilty by Reason of Insanity defense), and other miscellaneous evaluations. My contract with Napa County Mental Health requires me to to perform conservatorship evaluations.

- 2. Briefly, what is your educational background? I have a B.A. in psych from Wheaton College (Illinois), an M.A. in clinical psych from Northern Illinois University, and a Ph.D. in clinical psych from the California School of Professional Psychology San Diego (now part of Alliant University).
- 3. What interesting jobs have you had outside psychology? I've worked as a lifeguard, a night watchman for IBM, a Fuller Brush man, a cookware salesman, an assembly-line worker, a time-motion analyst for General Electric, a bartender, a "go-fer" for a Hollywood producer, a loan officer for Glendale Federal Savings, and a personnel officer for Southern California Edison. I think all of these jobs were "interesting," in that I learned important things about life from all of them but my greatest degree of satisfation, by far, has been as a psychologist.
- 4. What challenges do you see ahead for our profession? Specialization, specialization, specialization. For example, shortly after receiving my Ph.D. in 1975, (can it be THAT long ago?), neuropsychology was still in its infant stage. You could take a couple of neuropsych workshops from Ralph Reitan (as I did) and then hang out a shingle advertising yourself as a neuropsychologist! Now, of course, a neuropsych specialty requires years of study, and neuropsych even has its own ABPP (as does forensic psychology and a bunch of other specialties). So, I would say that finding a specialty that you love and are excited about is the main challenge facing psychologists today.
- 5. Why are you a member of NSPA? Because I have no life. Well, that's not totally true I met my lovely wife via NSPA need I say more?
- 6. Tell us one other interesting thing about you. I learned how to fly airplanes about 25 years ago.

CPA UPDATE

The Board of Directors of the California Psychological Association met on January 27 & 28, 2012 in Los Angeles. Napa-Solano Psychological Association is a chapter of CPA. The meeting was an exciting review of past successes and a look at future goals and objectives. After the usual business requirements the new Board and Officers for CPA were asked to agree to the responsibilities of their respective offices.

The new President (Dr. Craig Lareau) gave the opening remarks outlining his Goals for the new year:

1) Expanding CPA's communities (moving from a practice only trade organization to include all aspects of practice of the profession of psychology, 2) Health Care Reform and the new wave of integrated care, 3) Maintaining an emphasis on previous and ongoing objectives: Immigration Task Force Interdivisional Summit and collaboration Prescription Privileges Task Force

There was a brief discussion of some changes in this year's Convention in Monterey allowing for some time to spend in the city and surroundings and having the PAC dinner on Friday night. The Convention will be sporting 4 tracks: 1) Ethics, 2) Psychological consultation in Behavioral medicine, 3) Supervision, & 4) Forensic neuropsychological. Plan to attend but register soon as the rooms are being taken up rapidly!

The GAC gave their report on all of the Latest Legislative and Advocacy positions that CPA is preparing for the past, present and future proposed and pending legislation. The new Chair Dr. Dean Givens outlined the function and importance of the GAC support at the Chapter level and at the legislative level. Amanda Levy outlined the pending legislation supported or not supported by CPA. A presentation worth bringing to our Chapter.

The President and Executive Director then gave a very direct presentation on the duties and responsibilities of the Directors. Especially explained were the 1) Duty of care, 2) the Duty of loyalty and 3) the Duty of Obedience. The President (also a lawyer) was able to outline the legal aspects and responsibilities of the Directors of a "mutual benefit non-profit corporation" (such as CPA) are (especially the confusion of "representative" with "Director").

The Board approved the submitted revisions and updates to the bylaws of CPAGS, the Marin Chapter & Division 1.

Currently there is a bill to terminate the MCEP Accrediting Agency and require psychologists (like all of professions) to maintain records of required CE and be subject to a random audit at the time of relicensure. This is supported by CPA. The new language will allow you to take and count any training 1) Provided by an APA approved provider, 2) CME provider, 3) any course offered by CPA or 4) CPA approved provider. This will allow for CPA to establish 1) a CPA provider approver system to replace the MCEP and 2) CPA is considering offering a service to psychologists to maintain a copy of all CE records that you submit to be sent to the Board of Psychology. This would have a substantial impact on our budget.

We discussed the 3 day upcoming Leadership & Advocacy Conference in February in Sacramento. Sunday (sponsored by Division 1) is for the Chapter Presidents and the GAC representatives (or alternates), Tuesday is training, and Wednesday is open to all members to attend and meet their legislators.

The Board met in Executive session and at the end of executive session reported that they were pleased with the outstanding job of the Executive Director and asked the Officers to initiate discussions for an extension of her contract and her bonus for this past year.

The rest of the meeting was a continuation of the Governance Structure Task Force to develop, review and determine the essential aspects of the organization and structure of the Board of CPA. The body was divided into groups and debated or discussed essential features of the need for a competency based, knowledge based Board, the need for representation from the regions and the functions of CPA. This has been a long and winding road with many nuances. It is a look to establish CPA on the forefront of psychology in California for the next twenty years!
